<u>Staff Reports</u>: Director Lynn proposed attending the annual FRPA conference. City Commissioner Bobbie Spratt made a motion to approve the trip, which was seconded by School Board Member Paul Samerdyke. The motion passed unanimously.

Director Lynn also suggested switching the security cameras at Forrey to Ring in order to reduce costs. City Commissioner Bobbie Spratt moved to approve the change, with a second from City Commissioner Jackie Ratica. The motion carried unanimously.

City Commissioner Bobbie Spratt made a motion to appoint County Commissioner Emory "Rowdy" Howard as Chairman of the Board. School Board Member Paul Samerdyke seconded, and the motion was unanimously approved.

<u>Hearing of the public</u>: Cynthia Cerda, President of LaBelle Youth Soccer Inc., expressed concerns about maintaining the fields now that the game fields are open to the public. After discussion, County Commissioner Mitchell Wills made a motion to obtain a bid for a chain-link fence to create an additional field. City Commissioner Bobbie Spratt seconded the motion, and it was unanimously approved.

Amber Bass, speaking on behalf of the LaBelle Longhorns, stated the league's need for a pole barn and a new scoreboard. She noted their willingness to raise funds to help with the construction of the pole barn. School Board Member Paul Samerdyke made a motion to grant permission for the fundraising efforts, which was seconded by City Commissioner Jackie Ratica. The motion carried unanimously.

Beatrice Hernandez, President of the LaBelle Longhorns, brought up several issues regarding the football field and concession stand, noting that upgrades are needed.

Raymond Marroguin Jr. highlighted the heavy workload being handled by the Director and emphasized the need for additional support and greater accountability from others involved.
